

Vehicle Damage Agreement

ALL VEHICLE DAMAGE IS THE RESPONSIBILITY OF THE DRIVER

Students are responsible for damages to vehicles and property of the RallyPro Performance Driving School at The FIRM (The FIRM). Students may elect to either purchase a damage limiting plan, or agree to pay a deposit and cover the full damage costs. The costs of these options are defined in Table 1 and apply to EACH vehicle the student will be driving each day.

Therefore, prior to the start of your class you must select one of the following two options:

☐ OPTION 1 – Purchase a Damage Cost Limiting Plan

You will be charged the daily fee listed in Table 1, for each vehicle type used, prior to start of your class. If damage occurs, the damage cap amount shown in Table 1 represents the maximum amount you would have to pay for damages regardless of the amount of actual damage. Cost Limiting Fees are per day, so if you have a two-day course with a 2WD vehicle on day one, and a 4WD vehicle on day two, your fee would be \$100 for day one and \$150 for day two for a total of \$250.

☐ OPTION 2 –Post a Damage Deposit and Agree to Pay All Damage Costs

You will be charged the damage deposit listed in Table 1 for each vehicle used prior to the start of your course. This may not be the maximum amount for which you will be liable if you damage a vehicle. You are liable for the full amount of all damages and the damage deposit will be applied towards the full amount. Your total loss cost is also listed in Table 1 and that cost represents the maximum payment you would have to make if the vehicle is totaled. Upon completing the course, any unused portion of the damage deposit will be refunded to you. Damage deposits are per day, so if you have a two-day course with a 2WD vehicle on day one, and a 4WD vehicle on day two, your damage deposit will be \$1,500 for day one and \$3,500 for day two for a total deposit of \$5,000.

	c. If the repair/replacement cost is greater that the damage deposit, the balance will be to be paid to The FIRM by the				
	student herein named within seven (7) days of receipt of invoice by The FIRM.				
	d. If the invoice is unpaid after that period,	The FIRM has the right to obtain payment in full from the student.
